PRODUCT DESCRIPTION

JTAPE Customising Tape uses a thermally stablised PVC backing with a rubber based pressure sensitive adhesive. The product has 8 lengths of pre-cut fine line masking tape - allowing a multitude of curved patterns to be created when customising vehicles. It is highly flexible, easy to curve and will hold and cleanly remove from surfaces in temperatures up to 132°C/270°F for at least 30 minutes. After demasking, it will leave no residue and a sharp, clean separation line.
